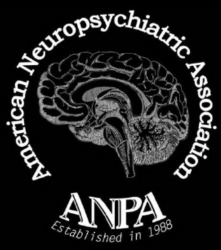

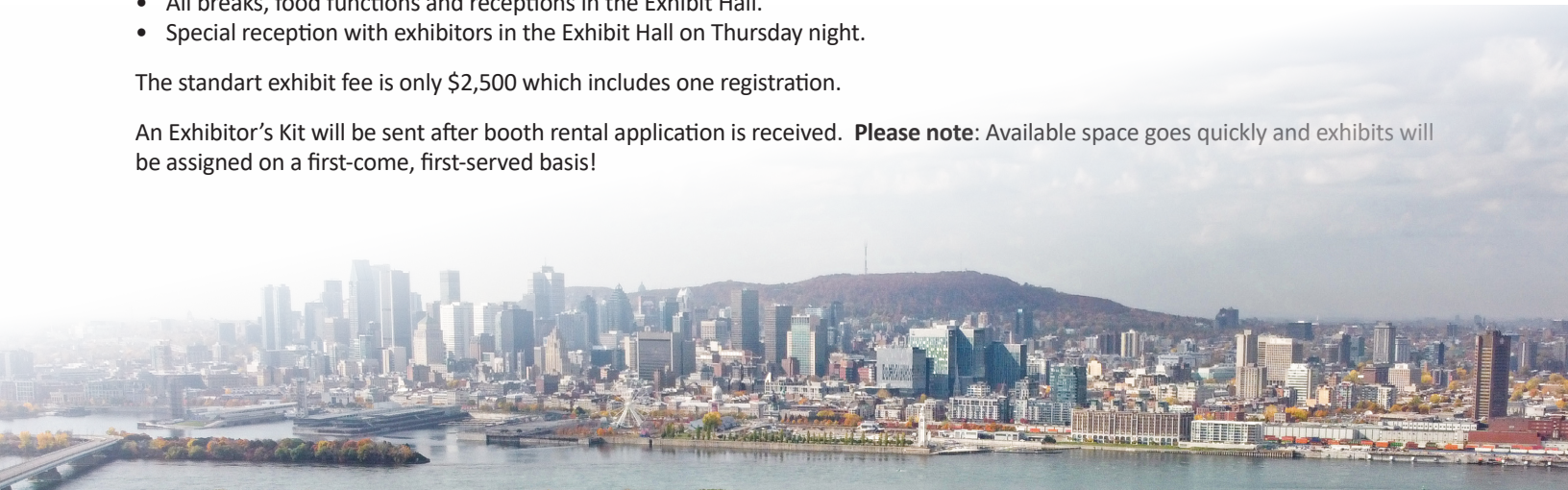

## SATELLITE SYMPOSIA

**Innovations in medical practice occur during and after planning of the scientific sessions for the ANPA Annual Meeting. Such innovations may be communicated to medical practitioners through satellite symposia.**

**Eligibility:** Organizations wishing to hold a satellite symposium during ANPA's Annual Meeting are required to submit the ANPA Satellite Symposium Application Form contained in this prospectus **and to obtain approval from ANPA.**

Upon the approval of ANPA, the organizer may compose its own branded session during designated 60-90 minute time slots. These satellite symposia will be promoted on all official ANPA signage, web-based materials, and in ANPA communications with meeting attendees.

ANPA will assign room space within the meeting hotel for use by satellite organizers. Due to space limitations, it is likely that satellite symposia will take place in the same rooms as ANPA's general sessions. Therefore, each satellite symposium organizer will need to coordinate their event closely with the ANPA administrative office.

**Promotion/Marketing:** The satellite symposium is encouraged to promote and market their symposium to generate attendance. Approved satellites will be listed and included in the schedule of events on the ANPA website and related meeting materials on on-site signage. Organizers may also provide a one-page promotional flyer (at organizer's expense) for inclusion in the registration materials provided to meeting participants at the time of their check-in to the meeting. Organizers may display two independent easel-mounted promotional signs during the annual meeting.

The satellite symposium organizer may provide food and beverages for attendees at that organizer's expense. Please note that ANPA will not provide any food and beverage service during designated satellite symposium times.

The sponsoring organization must:

- fulfill organizational and financial obligations in advance of the meeting,
- hold ANPA harmless from any and all claims that may result from the satellite symposium session,
- provide high-quality scientific information for healthcare providers attending the satellite symposium,
- complete and return the ANPA Satellite Symposium Application Form included in this prospectus, and
- include the qualifying statement contained on the ANPA Satellite Symposium Application Form in all promotional material for the satellite symposium (see last page for exact language).

The application contained in this prospectus must be completed and submitted to ANPA for review by its Program Committee and Executive Committee. Notification on submitted proposals will be provided within two weeks of submission by the proposed satellite symposium's organizer.
